For the roles Gyorgy played for ICSOBA over the decades he obtained free registration to the future ICSOBA events.

When writing this Foreword, just a month and a half after our 2018 Belem Conference, it's the time for ICSOBA Board to distil and ingest the feedback received from all of you to ensure ICSOBA Conference is and stays wholly and truly YOUR Aluminium Conference.

To this end, you gave us this year again an amazing number of suggestions through the Belem satisfaction survey for which I would like to warmly thank you again for your participation (54% response rate) but also for your numerous suggestions. You will read the highlight of the survey in this NEWSLETTER.

We are currently in the process of sorting, grouping and ranking your suggestions, but there is already one message coming loud and clear: the ICSOBA DNA does not need to be changed. That is:

- *Balanced program between Upstream (B&A) and Midstream (Carbon and Reduction);*
- *Move ICSOBA conference where Aluminium action take place;*
- *Field trip option.*

This message is also perfectly aligned with the one we got from the representatives of ICSOBA Corporate Members who met in Belem for the first ICSOBA Corporate Members Council. As of today, 19 Companies are supporting ICSOBA Strategy through their engagement on the long run.

Adding the suggestions from the Council and your suggestions will ensure ICSOBA Strategy and Strategy Deployment will strive to our vision to be The Technology Conference of the Aluminium Industry, for the Aluminium Industry.

As part of this Strategy, the conclusion of an MOU with Quartz Business Media for an ICSOBA session during 2019 Future Aluminium Forum to be held on 22nd and 23rd May 2019 in Warsaw, Poland is a testimony of ICSOBA engagement to support development trends of automation and digitalisation in Aluminium Industry. This session, which was introduced in Belem, will deal with "Aluminium 4.0: when process approach meets data-driven approach in mining, refining and smelting". We encourage all of you to submit presentation and attend this forum.

Making the changes required to ensure ICSOBA Conference transforms itself in accordance with the needs of the new development trends, whilst keeping up with our DNA which ensured the success of ICSOBA for the last 55 years is ICSOBA Board permanent objective.

Another testimony is the collaboration with Non-Ferrous Metals and Minerals of Siberia for the organisation of the 37th International Conference and Exhibition of ICSOBA which will be held from 16th to 20th September, in Krasnoyarsk, Russia hosted by UC RUSAL.

Highlights of the year 2018

- A very successful conference was organized in Belem, Brazil in October 2018, in which 225 delegates participated with 99 papers presented, and which was supported by numerous sponsors, with Hydro as the host sponsor. 85 delegates took part in three field trips to Paragominas bauxite mine, Alunorte refinery and Albras smelter.
- TRAVAUX volume No 47 corresponding to the Belem conference was published with 1044 pages. The TRAVAUX content and copies of presentations were handled to the delegates on pendrives.
- The Payment Policy was revised and is available on the ICSOPA website.
- Stripe credit card payment system was introduced in order to optimize registration process and payment by delegates.
- New guidelines for presentation and publishing a paper were elaborated.
- The ICSOPA website was improved and is constantly updated. A version of the ICSOPA website for mobile devices was created.
- MOU was signed with AAI (Aluminium Association of India) to support INCAL 2019 organization to take place in Bhubaneshwar, India next January. A similar MOU agreement was signed with Quartz Business Media regarding the ICSOPA contribution to the 2019 Future Aluminium Forum in Warsaw, Poland, next May.
- ICSOPA continued bilateral agreements with several media partners.
- ICSOPA was represented and promoted at Metal Bulletin (Montego Bay, Jamaica), and TMS.
- Two communications highlighting ICSOPA and its mission were published in international journals (AICircle and Aluminium Today).
- Publication of 2017 selected papers was accomplished in “Metals”.
- Marketing partnership agreement was established between ICSOPA events and AICircle.
- An article about the ICSOPA 2017 conference was published in The International AI Journal.
- Two NEWSLETTERS were issued (January 2018, June 2018) and circulated to members.
- ICSOPA’s past fiscal year (2017) and corresponding financial activity was revised by Gariépy & Bussière CPA Inc. chartered accountants. The financial statement was filed with Revenue Canada and Revenue Quebec. The Revenue Canada and Revenue Quebec confirmed that ICSOPA does not owe any tax for 2017.
- ICSOPA’s Annual Report (2017) and Bylaws were filed with Industry Canada and Registraire des entreprises Québec.

Post Conference Note - the 36th ICSOPA Conference and Exhibition in Belem, Brazil

Since 1963 ICSOPA (The International Committee for Study of Bauxite, Alumina and Aluminium) has organized 35 international events in different places of the world. For the first time, ICSOPA came to Brazil in 1998 and the event took place in Sao Paulo. Then, the Belem symposium in 2012 was the second on record on the Brazilian soil. The selection of Belem, the capital of the Para state of Brazil for the 36th International Conference and Exhibition, follows ICSOPA’s practice of rotating the venue of International Meetings to countries that play an important role in the global aluminium industry. This year, ICSOPA came to Brazil to recognize strong progress that this country

has made, in the aluminum industry but also in general. Brazil is the third largest bauxite and alumina producer behind Australia and China.

The 36th International Conference and Exhibition of ICSOBA was held in the period 29 October – 1 November. The Conference obtained support from Hydro, the host sponsor and attracted 225 delegates from 26 countries. From Brazil alone 95 delegates contributed. Very high-quality papers were selected for presentations (99) and published in the volume 47 of TRAVAUX conference proceedings. During the Conference, an Exhibition of latest technologies, equipment and other devices for the bauxite, alumina and aluminium industry took place with 12 participants. The last day of the conference saw three field trips to Paragominas bauxite mine, Alunorte alumina refinery and Albras smelter.



Organizers

The staging of this conference could not have been possible without the extraordinary effort of the organizing committee. The subject organizers this year are Robert LaMacchia and Andrey Panov (bauxite and alumina), Matthieu Arlettaz (carbon), and Vinko Potocnik (electrolysis).

The technical part was assured by a team led by Michel Reverdy, Program Director. Michel and Vinko Potocnik both of EGA, Dubai did an outstanding job again this year putting together the conference technical program and TRAVAUX proceedings. The volume No 47 of TRAVAUX that I have in my hand has 1044 pages of your contributions with the editorial quality the highest possible. We are pleased to let you know that this year we have selected 99 different papers that are published in TRAVAUX.

On behalf of the Organizing Committee we also want to express our great appreciation to the authors of papers. Without the authors, the conference would not have la raison d'être. Special thanks go to the paper reviewers and session chairs (Steve Healy, Alessio Scarsella, Brady Haneman, Stephan

Beaulieu, Linus Perander, Roman Dussel, Martin Segatz, Patrice Cote and Dagoberto Severo). We would also like to acknowledge the priceless contributions of: the remaining members of the Board of Directors: Andrey Panov, Houshang Alamdari, and BS Pani, on the part of the Board of Directors, Dipa Chaudhuri (executive secretary) - as well as the administrative staff from ICSoba (Barbara Feret, Dany Vanvoren and Marie-Claude Goyette) and Hydro (Silene Vendrasco, Pablo Azevedo).

ICSoba Medals

On ICSoba's 50th anniversary in 2013, the Awards Committee decided to produce commemorative medals (see below). The new "ICSoba Commemorative Medal" is 70 mm in diameter and takes its inspiration from two past designs. On one side are the embossed portraits of Pierre BERTHIER, Karl Joseph BAYER, Paul Louis Toussaint HEROULT and Charles Martin HALL. On the other side are the emblems of ICSoba and the World, the full ICSoba name, the name of the person awarded and the year of bestowal.



As in the past, the "ICSoba Commemorative Medal" constitutes a special recognition and may be awarded only to a small number of recipients each year. The medal may be awarded to those members who achieved significant scientific or practical results within the field of work, or who notably strengthened ICSoba organization or promoted its international scientific and industrial cooperation. The name of the awarded person is inscribed on the medal, and the awarding event is published in the NEWSLETTER.

Three medals were awarded in Belem to:

1. **Raphael Vieira da Costa – Hydro Brazil** in recognition of welcoming ICSoba in Belem in October 2018, facilitating the organization of the highly successful conference, and seeing to ICSoba's prosperity and growth.
2. **Matthieu Arlettaz of R&D Carbon** in recognition of his introduction of modern tools (ConfTool, Stripe, Whova), which revolutionized ICSoba conference administration and his contribution to organization of the highly successful events, thus seeing to ICSoba's prosperity and growth.
3. **Sudipta Chaudhuri (Dipa)** for her long-term commitment to ICSoba, and for her tireless efforts in promoting it and its mission, thus seeing to ICSoba's prosperity and growth.

Three Al Maple Leaf dishes with ICSoba name were offered to the visited plants as tokens of appreciation for hosting ICSoba delegates. This year the dishes were awarded to Paragominas bauxite mine, Alunorte alumina plant and Albras smelter.

The Best Paper Awards

At the end of the conference six papers were announced for the best paper award. The awards are dedicated to recognizing outstanding papers across the entire program. Four subjects were considered: bauxite and alumina, bauxite residue, carbon and electrolysis. The subject organizers of each stream: Robert LaMacchia and Andrey Panov (bauxite and alumina), Mathieu Arlettaz (carbon) and Vinko Potocnik (electrolysis) made their selections. Given the breadth, diversity and quality of the nominations, the job of picking winners was quite difficult. Two aluminium electrolysis papers were awarded due to the larger number of papers in this subject. The recipients are:

Plant Visits

Hydro is a global aluminium company with production, sales and trading activities throughout the value chain, from bauxite, alumina and energy generation to the production of primary aluminium and rolled products as well as recycling. ICSoba 2018 Satisfaction Survey

Following the event, an online Belem conference satisfaction survey was carried out among the participants. The comprehensive results of the survey composed of 38 questions lead to the selected conclusions as follows:

- Response rate of 54% demonstrates the overall interest from delegates to ICSoba organization and conferences (vs 53% in 2016 and 62% in 2017).
- ICSoba DNA key elements (i.e. balanced upstream/midstream; rotating conference place, field trips) are overwhelmingly approved.
- Keynote session, technical quality and content, applicability, as well as innovative nature of the papers are well rated (all around 70%). Leveraging digital tools received 74% support.
- Producers were the most represented alongside with a sharp decrease from equipment and technology suppliers (from 39% last year to 20% in Belem).
- Registration process, staff support, and networking obtained one of the best ratings. Whova is seen as an additional help in this field and is overwhelmingly seen as useful or very useful (81%).
- Very good rating was obtained regarding organization, conference materials (paper bags) and payment process through ConfTool, followed by exhibition and field trips.
- Intensive use of social media and interaction with media partners, were suggested for improved visibility.
- Having a theme for the conference, organizing workshop or webinars received mixed reactions.
- Points for improvement are: conference logistics (microphone management) and ICSoba website.
- Forecast to attend the next year event in Krasnoyarsk is 56%.



Rusal and Russia Aluminium Industry

Birth of Russian aluminium industry took place in 1932 with the creation of Volkhov aluminium smelter near Leningrad. Since that time, over 10 alumina refineries and 15 aluminium smelters have been built in USSR / CIS countries using domestic and imported raw materials. The unique feature of Russian aluminium industry is that the absence of high quality local bauxites and strategic reasons led to creation of unique technologies to process domestic low-grade bauxites and non-bauxitic raw materials such as nepheline, clays and alunite. The nepheline technology is waste-free, allowing converting all ore components to useful products like soda ash and cement. There are also developments to extract scandium oxide, gallium and vanadium pentoxide while processing bauxites.

Russian Aluminium Company, RUSAL is now a leading global aluminium producer of primary aluminium and alloys. In 2017, UC RUSAL accounted for approximately 5.8 % of global production of aluminium and 6.3 % of alumina. UC RUSAL employs 61 000 people in 20 countries across 5 continents. The Company’s production chain is vertically integrated and begins at the bauxite and nepheline ore mines, then moves through the alumina refineries, the aluminium smelters and casting houses, the foil mills and ends at a packaging and wheel production centers.

One of the Company’s main priorities is becoming a global leader in terms of aluminium production efficiency whilst still maintaining one of the lowest carbon footprints in the industry. To achieve this, UC RUSAL is investing in in-house R&D and is implementing RA-550 smelting technology and revolutionary inert anode technology, new technologies of alumina production and bauxite residue valorization. The Company is also developing new products, including new types of alloys and is upgrading its production facilities





Visa Support

How to obtain a Russian business visa

To obtain **the business visa** to Russia you will need to receive the official invitation from the company-organizer (Light Metals Ltd.), which is issued by the Department of the Federal Migration Service of Russia. Light Metals Company will file a petition to the Department after that the Federal Migration Service will start preparing the invitation. This procedure takes **22 working days**, because the documents should be checked by the Ministry of Foreign Affairs of Russia.

To file the petition please send to the organizing committee the following:
1) Completed Visa form 2) Scanned copy of the main page of your passport,
3) Payment of registration fee and visa support fee (**30 euro per 1 participant**)

After the invitation is ready the organizing committee will send you the electronic version of it by e-mail. Then you should print it and apply for a business visa to the Embassy of Russia in your country. Please note that the official invitation does not guarantee you will be granted a visa. Organizing committee cannot send the letter to an embassy or consulate for you nor can we contact the embassy or consulate on your behalf. It is the sole responsibility of the participant to obtain the necessary paperwork for entry to Russia.

How to obtain a Russian tourist visa

To obtain the tourist visa you will need to receive the tourist voucher from any travel agency (Russian or foreign). It takes 1-2 days, and then you can apply for a visa to the embassy of Russia in your country.

Note! At applying for a tourist visa you should indicate that the aim of your travel is tourism. If you need the support of the organizing committee with getting the tourist voucher of the Russian travel agency, please send the following: 1) scanned copy of the main page of your passport, 2) Payment of registration fee and visa support fee (67 euro per 1 participant).

Election to the Board of Directors

Authors

- ▣ There are no fees or charges for manuscript processing and/or publishing papers in TRAVAUX. Templates for abstracts, papers and presentations, as well as the submission procedures are clearly stated on the website. Authors must comply with the Templates.
- ▣ Each paper is accompanied by a presentation which must be presented at the conference by one of the authors or in exceptional case by another delegated person.
- ▣ All abstracts, papers and presentations are reviewed in order to guarantee high quality and the authors should follow corrections and instructions from the reviewers.
- ▣ Citations of the text or figures should be referenced.
- ▣ Financial support and permission to publish can be acknowledged.
- ▣ Acknowledgment can be given to contributors to the paper or research who are not the authors.
- ▣ Authors should make sure that the published material has been reviewed and authorized by the companies or organizations contributing to the technical material or who gave financial support for the published research.
- ▣ If some of the content of a paper has been already published before, at least one third of material must be new for an ICSoba paper; otherwise the paper will be refused.

Review Process

- ▣ Subject Organizers are responsible for the review process in their subject. The Program Director is responsible for the review of Keynote papers. They can be assisted by nominated reviewers.
- ▣ The review process assures high technical quality of papers and presentations, as well as uniform formatting, defined in Templates.
- ▣ Reviewers should avoid conflict of interest with authors.
- ▣ Reviewers should point out relevant published work which is not cited in the paper.
- ▣ Reviewers should keep the papers confidential until they are published.

Editors shall identify and refuse the publication of papers that contain unsubstantiated, conflicting or misleading results and claims.

Editors shall accept a corrected version of a paper by the authors and make it available in appropriate electronic version.

ICSoba papers are not copyrighted and can be freely reproduced and distributed publicly. The papers from recent years are available on ICSoba website to which internet browsers also give access.
